94. Chair's welcome

The Chair welcomed everyone to the meeting and explained the meeting protocol.

95. Apologies for absence

Apologies for absence were received by Cllr Glendinning & Cook and acceptance of apologies was proposed by Cllr Graham, seconded by Cllr James with all in favour.

96. Declarations of Interest

There were no Declarations of Disclosable Pecuniary Other Registerable and Non-Registerable Interests from councillors on items on the Agenda and it was noted that there were no written requests for dispensations for Disclosable Pecuniary Interests nor dispensations granted.

97. Minutes of the previous meeting

Cllr Graham proposed that the minutes of Planning and Highways Committee meetings held on 3rd September & 11th September 2024 are adopted as a true and accurate record of the meeting. This was seconded by Cllr Saunders with all in favour.

99. Planning Applications to be considered

- 99.1 **DC/24/3130/CON**|Consultation Installation of new telegraph pole | Opposite 12 Winston Close Kessingland Suffolk NR33 7QU
- 99.2 **DC/24/3131/CON**|Consultation Installation of telegraph pole|Proposed Pole Site 1 Lloyds Avenue Kessingland Lowestoft Suffolk NR33 7TU
- 99.3 **DC/24/3134/CON**|Installation of telegraph pole|Proposed Pole Site 2 Lloyds Avenue Kessingland Suffolk NR33 7TS
- 99.4 **DC/24/3135/CON**|Consultation Installation of telegraph pole|Part Verge Opposite 181 Lloyds Avenue Kessingland Suffolk

Items 99.1 – 99.4 were discussed in mass by the councillors due to the nature of the applications. As there were no objections, Cllr Graham proposed that the council recommend that the installations went ahead. This was seconded by Cllr Saunders with all in favour.

99.5 **DC/24/3052/VOC**|Variation of Condition 2 of DC/88/2014/FUL (W2194/6.114) - Extension to occupancy period.|114 Seaview Holiday Estate Green Lane Kessingland Lowestoft Suffolk NR33 7RG

Councillors agreed that this item was to be deferred until the next meeting. Cllr James proposed further investigation was made into the occupancy period and this was seconded by Cllr Saunders with all in favour.

99.6 **DC/24/3005/FUL**|Change of use of the land for the siting of 8 static caravans and 8 touring caravans for Gypsy / Traveller occupation. Use of existing access. Associated hard and soft landscaping improvements with biodiversity enhancements.

Councillors had a full and frank discussion, and it was agreed to move a holding motion to request further information regarding possible flooding on the site. This was proposed by Cllr Graham and seconded by Cllr James with 1 abstention and 3 in favour.

Members of the public left the meeting at 11.05am.

99.7 **DC/24/2806/TPO**|Proposal: "1no. Lime (A on plan) -3m whole tree reduction. 1no. Sweet Chestnut (B on plan) - Reduce height by 3m and remove west side branches. 1no.Beech (C on plan) - Reduce west branches by 3m."|157 Church Road Kessingland Lowestoft Suffolk NR33 7SQ

Councillors noted that the work would be done by a professional arborist therefore Cllr Graham proposed that council recommended approval of this application, this was seconded by Cllr Saunders with all in favour.

DC/24/2532/VOC|Variation of Condition No. 2 of DC/20/3698/FUL - Single storey rear extension, loft dormer, front porch, cladding and render property - To change approved drawings 474_01A, 474_02C and 474_03C in order to include some amendments to the approved scheme, involving increasing the size of the rear extension, as per new drawings 1854 10 and 1854 20 B.|58 Whites Lane Kessingland Lowestoft Suffolk NR33 7TG

It was noted that this application has been approved as per KPC recommendation.
