## 60. Planning Applications to be considered

60.1 DC/24/2464/FUL | Retrospective application - Construction of an Outbuilding | Hillside Beach Road Kessingland Lowestoft Suffolk NR33 7RW Councillors discussed this application and several concerns were raised, one of which was the failure to comply with planning regulations in the first place and not going through proper procedures to start building. Concerns regarding overdevelopment and vehicle access, supporting neighbourhood objections. Cllr Saunders proposed that KPC recommend refusal of this application but if the ESC are minded to go against this recommendation then council would like to request that the outbuilding is to only be used as a main store in conjunction

with the main building and not to be used as a commercial building. This was seconded by Cllr Glendinning with all in favour.

60.2 DC/24/2532/VOC | Variation of Condition No. 2 of DC/20/3698/FUL - Single storey rear extension, loft dormer, front porch, cladding and render property - To change approved drawings 474\_01A, 474\_02C and 474\_03C in order to include some amendments to the approved scheme, involving increasing the size of the rear extension, as per new drawings 1854 10 and 1854 20 B. | 58 Whites Lane Kessingland Lowestoft Suffolk NR33 7TG

Councillors noted the amendments to the approved scheme and could see no reason to object. Therefore, Cllr Graham proposed that council recommended approval of this application, this was seconded by Cllr Cook with all in favour.

61.2 DC/24/2023/FUL | Conversion of stables to an annexe | Rose Cottage 42 Wash Lane Kessingland Lowestoft Suffolk NR33 7QY It was noted that this application has been permitted and the following condition

The annexe hereby permitted shall be used only ancillary to and in connection with the host dwelling, known at the time of this application, as 42 Wash Lane Kessingland Lowestoft Suffolk NR33 7QY and shall not be accessed, used as a holiday let or sold off separately from the main property unless further planning permission is applied for and granted.
